LIMITED POWER OF ATTORNEY

The undersigned, Eric J. Daniels, hereby appoints Chad Porter, Robert Petitt and Michael Andreasen of Burns & Levinson LLP of Boston, Massachusetts, and other designated attorneys and paralegals of such firm, as well as Brian Strem and Sarah Romano of EyeGate Pharmaceuticals, Inc., a Delaware corporation (the "Company"), and other designated agents of the Company, to be his true and lawful attorney-in-fact (his "Attorney") in his name and on his behalf to:

- (1) prepare, execute, acknowledge, deliver and file SEC Form ID's and any other documents necessary with the United States Securities and Exchange Commission on behalf of the undersigned to obtain filing codes for the undersigned;
